**Opening and Introductions**

**DES application** none

**Public Service of NH representative** (did not appear). PSNH is seeking permission to do routine maintenance on the interstate power lines between Sloper Road and Route 202A. It will involve some wetlands crossings to get to the poles involved. They will be replacing two wooden poles with taller steel poles to reduce the sag in the cables. Liz read from the application report they sent to DES. We approved of what they plan to do and how they plan to accomplish it so Liz has an answer for them if they get in touch.
