Opening and Introductions

The meeting was opened at 7:00 pm. A motion was made by Dave and seconded by Susan to accept the September 2014 **minutes**. Approved.

Old Business

Isinglass River Conservation Reserve - The Commission decided to go ahead with the “no horses” signs for the trail heads on the reserve. Mimi will forward examples that she has found. Bruce will check with the Bureau of Trails to see if they have signs. If not, Carolyn will check with AMI who made our “Pack it in, pack it out” signs.

Evans Mountain – To help with our discussion of what we want for the future of the Evans Mt. property, Liz suggested that we get together with Charlie Moreno, our forester, and George Lovejoy, the owner of the northern half of the mountain to see what they envision. Each of us is to write down what we see as the long term goals of the mountain so they are in mind for the next meeting. Liz will set up a meeting date with Charlie and George.

Town Forest – Six of us, (Scott, Dave, Mimi, Susan, Carolyn and Gordon Page) met at the Town Forest field to try to eradicate the Norway Maples growing at the verge of the forest. After a brief time we realized that there had to be a better way. We decided to use chain saws to take down the larger saplings before they could put out seeds and to either bush-whack the smaller plants or let them grow until they could be easily cut. Scott will check on the cost to rent a large size weed-whacker. Scott will email the Commissioners to set a date to do the cutting and piling of the saplings. It was suggested that the mother tree in the adjacent cemetery be girdled to stop the spreading of seeds.
