

## Regulations Governing Use of the Strafford Transfer Station and Recycling Center

State law requires that no one shall use the area unless an attendant is present. The gate shall be kept locked at all times when the area is unattended. Any person apprehended inside the Transfer Station/Recycling Center when closed shall be charged with criminal trespass, a class A misdemeanor, and be subject to a maximum penalty of one year in prison, and a \$2,000 fine (RSA 635:2).

Any person vandalizing the Transfer Station/Recycling Center shall be charged with criminal mischief which under certain circumstances, constitutes a class B felony that carries a maximum penalty of seven years in prison and a \$4,000 fine. (RSA 634:2).

Any person leaving trash outside the Transfer Station/Recycling Center gate or depositing along roads within the township shall be charged with littering, a class A misdemeanor and subject to a maximum penalty of one year in prison and a \$2,000 fine. (RSA 147:21 163:b:4,163:B:6).

Attendants shall refuse to allow any waste be deposited at the facility which, if accepted, would violate these regulations of any Federal or State laws or the Town of Strafford's regulations or ordinances.

If a Town of Strafford Transfer Station/Recycling Center sticker is not permanently affixed to the vehicle, the owner is subject to a \$20 fine for the first offense, and \$50 for each additional offenses.(RSA31:39).

Transfer of stickers Transfer Station/Recycling Center permits to unauthorized persons or misuse of permits is subject to a fine up to \$1,000.

Any person leaving prohibited or unacceptable materials at the Center will be subject to a fine of up to \$1,000. Any use of the facility for the deposit of trash not generated within Strafford is considered unauthorized. Violators shall be fined up to \$1,000 (RSA 31:30 and RSA 149M).

**All children under the age of 12 years old must remain in vehicles.**

**All patrons of the Strafford Transfer Station/Recycling Center are responsible for their own safety. Please wear proper footwear and be aware of your surroundings.**

## Strafford Recycling Center is for residential use only.

Admission to the facility is by **permit only**. Permits are free and require proof of residency (i.e. picture ID with Strafford address, car registration with Strafford address, tax bill with picture ID). Only vehicles present will be issued a permit.

**Permits are available at the Recycling Center ONLY and must be affixed to the vehicle upon issuance.** Please affix permit to the lower left side of driver windshield above inspection sticker.)

While recycling in the Town of Strafford is not mandatory, the Town strongly encourages residents to recycle any and all recyclable materials.
